HOW TO PLAY

STEP ONE

Select the

game.

STEP TWO

Choose your ticket type and select your numbers. You can choose Straight tickets (manually pick your numbers), Way tickets (multiple tickets in one), or Quick Pick (let the computer choose the numbers for you).

STEP THREE

Select the price you would like to bet per game, remember the Exacta Keno will be an additional 25¢ for every two consecutive games.

STEP FOUR

Select the number of games you would like to play, a minimum of two games is required, play up to 999 consecutive games.

Official Rules

- 1. Exacta Keno is a combination of two consecutive keno games.
- The Exacta Keno side bet is won when you catch the exact same number of winning spots on two consecutive games.
- Exacta Keno may be played at \$1.00 or more per game with an additional 25¢ wager for the Exacta Keno side bet (Total \$2.25).
- 4. To play more than \$1.00, the Exacta Keno side bet of 25¢ will increase by the multiple of your bet amount, Example: If your bet amount per game is \$3.00 (\$1.00 X 3 = \$3.00) then your Exacta Keno side bet will follow the same multiple (25¢ X 3 = 75¢). Resulting in a total bet amount of \$6.75 which includes 2 games at \$3.00 per game with the 75¢ Exacta Keno side bet.
- 5. You still win the normal game prizes, even if you don't catch the Exacta Keno.
- You can win an Exacta Keno bonus on 7 and 8 spot tickets, even if you don't catch enough numbers to win the regular games.
- 7. Winning tickets may not be cashed until all games on multi-race ticket have been played.
- 8. The maximum aggregate payout for the two consecutive keno games and the Exacta Keno side bet is \$50,000.
- 9. On Exacta Keno Way tickets, each way is a separate Exacta Keno side bet.
- The price per way is \$1.00, each two ways requires a separate Exacta Keno side bet at 25¢, computed separately, subject to the aggregate limit of \$50,000.
- 11. Official keno rules apply to Exacta Keno wagers.
