HOW TO PLAY

STEP ONE

Select the  game.

STEP TWO

Choose your ticket type and select your numbers. You can choose Straight tickets (manually pick your numbers) or a Quick Pick (let the computer choose the numbers for you).

STEP THREE

Designate your Golden Keno Ball™ from the selected numbers.

STEP FOUR

Choose the number of games you would like to play from 1-999.

STEP FIVE

Select the bet amount per game. Minimum bet amount is \$1.25.

Official Rules

1. The Golden Keno Ball™ must be designated by the player from the original numbers picked.
2. Win the Golden Keno Ball payout by matching your selected Golden Keno ball pick with the 20th number drawn.
