OFFICIAL RULES

EARNING ENTRIES

- Crescent Club members receive one (1) free entry into each drawing barrel for which they qualify and may accumulate one (1) additional entry for every one (1) base point earned in game play.
- Entries may be earned beginning at 12:00 AM on Sunday, October 29, 2023 through 4:00 PM on Sunday, November 26, 2023.
- Guests must deposit their entries at any Crescent Club kiosk to be eligible to win beginning at 10:00 AM each promotional drawing day.
- Entries earned for this promotion remain valid and available to deposit throughout the earning period.
- Additional entries may be awarded through special promotional offers.

\$1,000,000 DRAWINGS

- Fifteen (15) winners will be selected at random from a designated electronic drawing barrel between 12:00 PM and 4:00 PM on Sunday, November 5, 12, 19 and 26, 2023.
- Each winner, once present and verified, will be presented with an electronic game board with three (3) touchscreen reels. Winners activate and spin each of the reels to reveal on a single pay-line three (3) resting and final symbols. The combination of symbols will reveal the prize won.
