## OFFICIAL RULES

### \$1,000,000 Bracket Challenge

#### PARTICIPATION

- Participation is free for all Crescent Club members, 21 years of age and older with valid photo ID. Crescent Club membership is free.
- To participate Crescent Club members must first register online by visiting [snocasino.marchmaniaonline.com](https://snocasino.marchmaniaonline.com) beginning February 20, 2024, or by accepting an emailed invitation to play.
- Limit one (1) entry per person and/or email address.
- To register participants must provide identifying information, a valid email address, their unique Crescent Club player card number and must further agree to the promotion terms and conditions.
- All Crescent Club members receive one (1) free bracket submission. No purchases or payments are required to enter or win or claim a prize.
- Guests may earn up to two (2) additional bracket submissions per day between 12:00 AM on March 1, 2024 and 11:59 PM on March 14, 2024 as follows:
  - Earn 100 base points in slots and/or Table Games play. Limit one (1) additional bonus bracket submission per guest per day. Base points must be earned between 12:00 AM and 11:59 PM to qualify.
  - Place a qualifying wager of \$100 or more using the Snoqualmie Casino Sportsbook mobile application. Limit one (1) additional bonus bracket submission per guest per day. Wager must be placed between 12:00 Am and 11:59 PM to qualify.
- All Crescent Club members may participate in this promotion when they download and sign up for a Snoqualmie Sportsbook mobile application account for free.

#### HOW TO ENTER

- After a Crescent Club member registers or accepts an invitation for free they may proceed to the 'Make Picks' page [snocasino.marchmaniaonline.com](https://snocasino.marchmaniaonline.com) and submit their bracket selections anytime during the official entry period from approximately 7:00 PM on Sunday, March 17 (after the teams are announced) to 11:59 PM on Wednesday, March 20, 2024.
- Registration and bracket selections must be submitted online as outlined herein using a participant's personal mobile device or personal computer.
- No submissions will be accepted after the deadline for any reason.
- Confirming selections is required by using the submit button at the bottom of the page. Follow all additional instructions listed on the page, observing all posting deadlines.
- Participants may change their selections at any time before clicking on the 'submit' button. Once submitted online, selections are final and cannot be changed or altered.
- Complete the entry by filling out the brackets for the four (4) regions and final rounds of the Tournament, making sure to use the submit button. In order to fill out a valid bracket, participants must choose a winner for each match-up that is consistent with the prior match-ups.
- Should a tie occur for any prize, the tie-breaker will be the date and time of the bracket submission, the earliest submission date and time wins. Should a tie still result after using a date and time tiebreaker, a random drawing will be held among all tied participants.
- This promotion will award prizes based on the results of the 2024 NCAA Division I Men's College Basketball Tournament. On March 17, 2024, the Tournament's selection committee will seed the qualifying college basketball teams that will participate in the Tournament.

## **CONTEST SCHEDULE AND SCORING SYSTEM**

- Participants will attempt to select/pick the winning team for each of the games of the Tournament presented in the form of a bracket. Participants will earn points for each winning team correctly picked through their bracket. The number of points awarded will increase with each round of the tournament.
- Only the highest scoring bracket submission will be counted for each participant's final scoring position in the content.

## **HOT SHOTS**

### How to Play

- Participants play a video arcade-style game and virtually shoot balls into a basket to try to earn points. Participants are awarded between three (3) and seventy-five (75) bonus entries into the drawings.

## **FAST BREAK**
