### OFFICIAL RULES

#### PARTICIPATION

- Participation is free for all Crescent Club members, 21 years of age and older with valid photo ID. Crescent Club membership is free.
- To participate Crescent Club members must register online at [snocasino.com](http://snocasino.com).
- To register participants must provide identifying information, a valid email address, their unique Crescent Club player card number and must further agree to the promotion terms and conditions.
- Weekly picks must be made on a mobile device while on Snoqualmie Casino property within the qualifying periods to be eligible.
- Incomplete, missing or inaccurate information will result in forfeiture of submission.
- Each week of the eighteen (18) weeks during the promotion a predetermined number of 2021 National Football League regular season games occurring only on Sunday and Monday of each week that start at 1:00 PM Eastern Standard Time on Sunday or later will be included in the prediction pool for that week for a total of 246 eligible regular season games.
- Guests will be prompted to select their picks and choose a tie-breaker score to complete their entry. Tie-breaker scores are the total combined score of both teams of the Monday Night football game.

## \$1,000,000 CASH PRIZE

- Crescent Club members are eligible to win \$1,000,000 (40-year annuity) should a guest accurately predict the winning teams 204 out of 246 total 2021 National Football League regular season games included in the eighteen (18) prediction pool games listed in these promotional official rules.

## GENERAL RULES

- Predictions and submissions cannot be altered once submitted, all transactions are considered final.
- All predictions must be submitted thirty (30) minutes prior to the start of the first scheduled game for that week.
- Registration and creating an account to participate online is limited to one (1) account per guest. Duplicate accounts or accounts created using invalid, duplicate, missing, inaccurate or otherwise false information will be disqualified from the promotion.
- Each account must include a current Crescent Club account number. Accounts created without a valid Crescent Club number will be disqualified.
- Participants may access the current standings online at any time but must be on Snoqualmie Casino property to submit predictions.
- Participants are not required to make predictions each week.
- Should a participant qualify for and win the \$1,000,000 cash prize that prize shall be made in forty (40) annual installments without interest by a third-party vendor SCA Entertainment. SCA Entertainment is the sole proprietor and will conduct all transactions, business, installments, arrangements, payments, agreements with the winner at their sole discretion. - If any National Football League regular season games officially end in a tie, either team selected will count as an unsuccessful prediction.
- If any of the 2021 National Football League regular season games included as one of the eighteen (18) prediction pools is cancelled due to force majeure which prevents the conducting of that game said game will be replaced with another game or the rescheduled game.
- In the event that an entire week (or weeks) of games are cancelled and not rescheduled, the games will not be counted in the contest and the weekly prize monies will not be awarded.
- In order for a weekly prize to be awarded there must be a minimum of five (5) games played and counted. In addition, if there are less than five (5) games played and counted, that weeks games will not be counted for the Season Final.

- In the event that a game not included in the eighteen (18) weeks games identified as available for predictions be rescheduled onto a Sunday or Monday that game will not be counted in the contest.
- In the event that a game listed in the prediction pool for this promotion be conducted and completed in 55 minutes or less, that game will not be counted in the contest.
- In the event that participants select the same tie-breakers scores, the earliest date and time stamp of those participants submissions will determine the final winner.
- Each participant is responsible for recording and retaining their registration and log in information. Late predictions, inaccurate or partial predictions caused by failure to recall any part of a participant's log in information, personal mobile device malfunctions, or any other unforeseen circumstance causing an inability to submit predictions within the timeframe allotted will not be reconsidered for any reason. It is the sole responsibility of the participant to ensure location and device access to submit their predictions.
- All prizes must be collected in person at any Mr. Crescent kiosk. To collect any cash or FREEPLAY prize participants must present valid photo identification and/or a personal identification number.
