



## OFFICIAL RULES

### HOW TO PARTICIPATE

#### Step 1 Become a Crescent Club member

- All Crescent Club members receive one (1) free prop card

#### Step 2 Earn Bonus Prop Cards

- Earn daily prop cards when you play between January 8 and January 25

#### Step 3 Submit Online

- Complete your prop cards and submit between February 3 and February 11

### PARTICIPATION

- Participation is free for all Crescent Club members, 21 years of age and older with valid photo ID. Crescent Club membership is free.
- To participate Crescent Club members must have an email address on file or they must register online at [snocasino.pickems.com](https://snocasino.pickems.com).
- To register participants must provide identifying information, a valid email address, their unique Crescent Club player card number and must further agree to the promotion terms and conditions. This will be each qualifying guest's valid registration for the entire season.

### \$100,000 BIG GAME PROP CARDS

- All Crescent Club members receive one (1) free prop card. No purchases or payments are required to enter or win or claim a prize.
- Guests may earn one (1) additional bonus prop card beginning at 12:00 AM on January 8, 2023 through 11:59 PM on January 25, 2023 by each of the following:
  - Earning 100 base points in slot or Table Games play
  - Placing a qualifying wager of \$100 or more using the Snoqualmie Casino Sportsbook mobile application
- Limit one (1) bonus prop card for slot or Table Games play per guest per day.
- Limit one (1) bonus prop card for Snoqualmie Casino Sportsbook wagers per guest per day.
- Prop cards will present each participant with a series of twenty-five (25) questions pertaining to various outcomes or actions during the National Football League Championship game held on February 12, 2023.
- Cash prize for correct prop card answers are as follows:

- Prop cards will be available to submit online at [snocasino.pickems.com](https://snocasino.pickems.com) between 12:00 AM on February 3, 2023 and 11:59 PM on February 11, 2023. All prop card submissions are digital format.
- Results will be posted online on February 13, 2023 no later than 11:59 PM.
- Winners may claim their prize by visiting any Crescent Club kiosk beginning at 12:00 AM on February 15, 2023 and before 11:59 PM on February 22, 2023. Should any guest fail to claim their prize within the timeframe allotted, that prize is considered forfeit.

## **\$25,000 BIG GAME DRAWINGS | SUNDAY, FEBRUARY 12 | 12:00 PM**

- All Crescent Club members are eligible to participate.
- Crescent Club members receive one (1) free entry. Guests may accumulate one (1) additional entry for each one (1) base point earned in rated slot game or Table Games play, or for every one-hundred (100) dollars wagered using the Snoqualmie Casino Sportsbook mobile application beginning at 12:00 AM on Sunday, January 8, 2023 through 12:00 AM on Saturday, February 11, 2023.
- Three (3) winners will be randomly drawn on Sunday, February 12, 2023 at 12:00 PM and will receive the following:
  - One (1) winner will receive \$12,000 FREEPLAY
  - One (1) winner will receive \$8,000 FREEPLAY
  - One (1) winner will receive \$5,000 FREEPLAY
- Guests must deposit their drawing entries beginning at 10:00 AM on the day of the drawing to be eligible to win.
- Once announced, drawing winners have three (3) minutes to present themselves to the drawing official, should any winner fail to present themselves within the timeframe allotted or fail to present valid photo verification that win is considered forfeit and another winner will be drawn until that prize is awarded. ### **Touchdown trivia**

#### How to Play

- Participants are presented with a sports related trivia question each day, and four potential answers. Correct answers will be rewarded with between five (5) and thirty (30) bonus entries into the \$25,000 Big Game Drawings.

### **Long Bomb Challenge**

#### How to Play

- Footballs will be thrown at three (3) rings on the screen. The goal is to click on the ring that the ball is going through at the exact time that the ball passes through the center of the ring. Misses drain the power on the Power Meter, while successes increase the power on the Power Meter. The game continues until the participant runs out of power due to misses. Participants are awarded between nine (9) and four-hundred (400) bonus entries into the \$25,000 Big Game Drawings.

### **Special Teams Spin**

#### How to Play

- Participants spin a prize wheel and are awarded between five (5) and two-hundred and ten (210) bonus entries into the \$25,000 Big Game Drawings.

## **GENERAL RULES**

- All Crescent Club members may participate in this promotion when they download and sign up for a Snoqualmie Sportsbook mobile application account for free.

- Snoqualmie Casino is not responsible for persons not hearing their names if announced, some location within the property do not provide announcement coverage, it is the sole responsibility of that person to ensure they are in a location to hear drawing announcements.
- All times referred to throughout these rules are approximate.
- By participating in this promotion, guests agree to allow Snoqualmie Casino to use their image for promotional purposes. By signing a photo release form, winners additionally agree to allow Snoqualmie Casino to use their image and first name.
- Drawing winners will be given a cash option in lieu of the FREEPLAY prizes at half the value.
