OFFICIAL RULES

HOW TO PLAY

1. **Register** – visit the Sportsbook beginning **May 27, 2024 at 10:00 AM**
2. **Buy-In** – purchase up to ten (10) entries per guest per prize pool
3. **Make Selections** – visit the Sportsbook each week to 'beat the point spread' and earn points
4. **Win** – accumulate more points for selections vs. the competition

PARTICIPATION

- This promotion is open to all Crescent Club members, 21 years of age and older with a valid photo ID. Crescent Club membership is free.
- To register participants must provide identifying information, a valid email address, and their unique Crescent Club membership number. Once a participant has registered they are eligible to participate throughout the promotional period.
- Contestants may participate in the season long contest by paying a buy-in fee.
- Two (2) prize pools are available for contestants to buy-in for:
 - \$500 per entry – Prize Pool A
 - \$200 per entry – Prize Pool B
- Limit ten (10) entries per prize pool per person.
- All season entry fees may be placed beginning at 10:00 AM on Monday, May 27, 2024 and conclude on the Saturday prior to the first scheduled NFL regular season games of 2024 at 10:00 PM.
- Entry fees are non-refundable. Cash payments are required, no other tender will be accepted as payment.
- Contestants must purchase at least one (1) entry at the time of registration. Additional entries may be purchased until the deadline.
- Each entry shall be treated as a separate entry for all purposes, including prize distribution. Entries are non-transferable, and all participation and prize monies collected must be by the contestant, no proxies are allowed to submit selections nor collect any prize on behalf of the contestant.
- This promotion does not limit the total number of participants who may buy-in, only the number of buy-ins per contestant per prize pool. Participation in any prize pool does not limit nor exclude any contestant from participation in any other prize pool. Total buy-ins are subject to the prize pool and payout structure outlined herein. Snoqualmie Casino does not claim any portion of the total prize pool.

SELECTIONS

- Once a contestant has registered and purchased an entry they may submit weekly selections at the Snoqualmie Casino Sportsbook.
- Contestants select five (5) teams whom they believe will win against the Snoqualmie Casino Sportsbook contest line each week. Correct selections against the point spread will count as two (2) points. Ties or pushes against the point spread will result in one (1) point. Incorrect selections against the point spread will result in zero (0) points. Points do not apply, nor are earned or lost due to any scheduled game being forfeited, canceled, or postponed.
- Contestants may not select both sides of the same game on a single entry.
- Contestants must submit their weekly selections at the Snoqualmie Casino Sportsbook once the contest lines are available between approximately 3:00 PM on Tuesday and 10:59 PM on Saturday. Contestants who fail to submit their selections before the deadline will be awarded zero (0) points for that week.
- Any game played before Sunday of a selection will enforce an entry submission cut-off twenty (20) minutes before kickoff.
- Contestants will submit their selections at the Snoqualmie Casino Sportsbook using a designated computer station and accessing their account. Submissions are not available electronically at any other location or access point.
- Season winners will be determined by the total number of points accumulated during all eighteen (18) weeks of the National Football League regular season. Each contestant is awarded one (1) 'bye-week' which will result in discarding their lowest scoring week from their total season score.
- Contestants cannot alter, void, change, cancel or edit any selection once submitted. All submissions are final.

HALF SEASON PRIZE STRUCTURE

- Half Season prizes are paid out to the contestants based on their position ranked in order of highest to lowest number of total points accumulated during a defined period. First Half is considered to be the first half of the total weeks played during the regular season. The Second Half is considered to be the total weeks played in the last half of the regular season. Should the total number of weeks for the regular season be an odd number, the second half of the season is considered to be the last half of the regular season plus one (1) week.
- Of the total buy-ins for each prize pool for the contest, the following will be designated to Season Half prizes;
 - Prize Pool A: 10%
 - Prize Pool B: 20%

- Of the designated Half Season prize pool, 50% will be delegated to the First Half and 50% will be delegated to the Second Half.
- Half Season prizes will award contestants based on accumulated points ranked from highest to lowest as follows;
 - Prize Pool A: first place – 100%.
 - Prize Pool B: first place-50%, second place-30% and third place-20%.

OVERALL SEASON PRIZE STRUCTURE

- All prize distributions are based on percentages of the total prize pool and their respective places.
- Of the total buy-ins for each prize pool for the contest, the following will be designated to Overall Season prizes;
 - Prize Pool A: 90%
 - Prize Pool B: 80%
- Overall Season prizes are paid out to contestants based on accumulated points ranked from highest to lowest, plus the last place ranked contestant and those contestants who place on a bonus place where applicable.
- The Overall Season prizes will award contestants based on accumulated points ranked from highest to lowest as follows;
 - Prize Pool A: first place-62%, second place-22%, third place-5%, last place-3% and Playoff Challenge-8%.
 - Prize Pool B: first place-50%, second place-20%, third place-9%, fourth place-5%, fifth place-3%, last place-3% and Playoff Challenge-10%.
- The contestant who ranks the lowest based on accumulated points throughout the season and who submitted at least one (1) selection for each of the eighteen (18) weeks will be paid a prize equal to 3% of the total in each of their respective prize pools; Prize Pool A and Prize Pool B, as designated for the Overall Season prize structure.

PLAYOFF CHALLENGE

- Of the total buy-ins for each prize pool, which are designated for the Overall Season Prizes, the following will be designated to the Playoff Challenge:
 - Prize Pool A: 8%
 - Prize Pool B: 10%
- The top ten (10) highest ranking contestants from the overall season will remain eligible to continue making weekly selections throughout playoffs, including the National Football League Championship game.
- Eligible Playoff Challenge contestants must make selections for all scheduled games each week for their entry to be submitted. For example; week one consists of six (6) scheduled games, therefore the contestant must make selections for all six (6) games, and so on.
- The Playoff Challenge selection schedule will be released and available at least two (2) days prior to the first scheduled playoff game.
- All entries must be submitted at least twenty (20) minutes prior to the start of the first game of that week.
- In the event of a tie for 10th place – all contestants tied for that position will move on to the Playoff Challenge.
- The Playoff Challenge will award contestants based on accumulated points ranked from highest to lowest as follows;
 - Prize Pool A: first place-100%.
 - Prize Pool B: first place-100%.

GENERAL RULES

- This promotion is open to all Crescent Club members, 21 years of age and older with valid photo identification.
- Incomplete, missing, or inaccurate information will result in forfeiture of submission.
- All prizes are non-transferable and non-negotiable.
- Submissions cannot be altered once submitted, all transactions are considered final.
- Registration and creating an account to participate is limited to one (1) account per guest. Duplicate accounts or accounts created using invalid, duplicate, missing, inaccurate, or otherwise false information will be disqualified from the promotion.
- Each account must include a current and valid Crescent Club account number.
- The National Football League regular season must consist of nine (9) weeks for this promotion to be valid. In the event of cancellation before nine (9) complete weeks prorated entry fees will be refunded. In the event of cancellation after nine (9) weeks the unfinished in-season prize monies will be diverted into the final prize pool.
- Participants may access the current standings at snocasino.com at anytime from anywhere they have internet access. However, all selections must be made in person at Snoqualmie Casino Sportsbook during the active selection period.
- Participants are not required to make selections each week to win any prize except the overall season last place prize in which all eighteen (18) weeks must include at least one (1) selection being submitted for that contestant.
- All participant(s) and winner(s) are subject to verification and subject to the terms and conditions outlined herein. Determination of winner(s) and verification of eligibility

- and compliance with these terms and conditions will be conducted by Snoqualmie Casino, agent or assignee, whose decisions will be final and binding in all respects.
- Entry fees will not be refunded for any reason(s) other than the cancellation of the promotion or as otherwise outlined herein.
 - For contest purposes, all games are considered action despite a location change. In the event of a game cancellation or postponement, the game(s) must be played by 11:59 PM on Tuesday of the current week to be applied toward contest standings, otherwise, the contestant will be awarded zero (0) points for that game.
 - Standings will be updated each Tuesday during the promotional period at approximately 3:00 PM. Standings are available to view at club.snocasino.com.
 - Tie-breaking rules will be applied to determine first place Overall Season winner only. In the event of a tie for first place in the overall season, the winner will be determined based on the entrant who accumulated the most contest wins during the eighteen (18) weeks of the regular season. If the total wins accumulated during the eighteen (18) weeks are equal then the tiebreaker will revert to the entrant who has accumulated the most winning weeks. A winning week is defined as accumulating more than 5.5 points in a given contest week. If total winning weeks accumulated through weeks 1-18 are equal, then the tiebreaker will revert to the entrant who has accumulated the most undefeated (5-0) weeks during the regular season. If the most undefeated (5-0) weeks accumulated during weeks 1-18 are equal, then the tiebreaker will revert to the entrant who has accumulated the most undefeated (4-0-1) weeks during the regular season. If most undefeated (4-0-1) weeks accumulated during weeks 1 - 18 are equal, then the tiebreaker will revert to the entrant who has accumulated the most (4-1) weeks during the regular season. In the event of a tie after the application of all tiebreakers, multiple first-place winners will be declared, and the aggregate prize monies will be split equally amongst the number of entrants tied for first place.
 - All ties for Season Half prizes and/or Overall Season prizes other than first place overall will be split evenly among all entrants in the tie. (For example, if two (2) entrants are tied for second place the prizes for second and third place will be added together and split evenly. Official finishing positions will be denoted as 'tied second' in the rankings and the next finisher would finish fourth and so on.
 - Each participant is responsible for recording and retaining their registration and login information. Late predictions, inaccurate or partial predictions caused by failure to recall any part of a participant's login information, personal mobile device malfunctions, or any other unforeseen circumstance causing an inability to submit predictions within the timeframe allotted will not be reconsidered for any reason. It is the sole responsibility of the participant to ensure location and device access to submit their selections.
 - In the event of a mechanical, technical, or otherwise unforeseen malfunction that inhibits the ability for a contestant to submit their selections electronically using the designated computers located at the Sportsbook, selections may be submitted in person at the Snoqualmie Casino Sportsbook counter manually as deemed necessary and at the total discretion of Sportsbook management.
 - A copy of the contestant's selections will be made available either by email or as a copy of the paper selection submission.
 - Winners may be given the option to have their prizes awarded as a direct deposit onto their Snoqualmie Casino Sportsbook mobile account.
 - All prizes must be collected in person at any Crescent Club kiosk. To collect any cash prize participants must present valid photo identification and/or a personal identification number and/or tax information at the Main Cage with their prize voucher.
 - Prizes not redeemed within the timeframe allotted are considered forfeit.
 - All prizes are non-transferable and non-negotiable.
 - All times referred to throughout these rules are approximate.
 - By participating in this promotion, guest(s) agree to allow Snoqualmie Casino to use their image for promotional purposes.
