### **OFFICIAL RULES**

- Open to all Crescent Club members with valid photo identification, 21 years of age or older.

### **Earned Entries**

- Crescent Club members receive one (1) free drawing entry and one (1) additional drawing entry for every one (1) base point earned in game play. Entries may be earned beginning 6:00 AM on Saturday, April 17, 2021 through 9:59 PM on Sunday, May 9, 2021.
- Deposit entries at any Mr. Crescent kiosk beginning at 8:00 AM on Sunday, May 9, 2021.
- Additional entries may be awarded through special promotional offers.

### **Designer Bag Drawings**

- Fifty (50) winners will be randomly drawn between 10:00 AM and 10:00 PM on Sunday, May 9, 2021.
- Drawn winners must be actively playing at a slot machine or table game at the time of drawing to be eligible to win.
