OFFICIAL RULES

- This promotion is open to all Crescent Club members, 21 years of age and older with a valid photo ID.

EARNED ENTRIES

- Crescent Club members receive one (1) free drawing entry and one (1) additional drawing entry for every ten (10) base points earned in game play. Entries may be earned beginning 12:00 AM on Sunday, April 16, 2023 through 10:00 PM on Sunday, May 21, 2023.
- Deposit entries at any Crescent Club kiosk beginning at 8:00 AM on all promotional drawing days.
- Entries earned for this promotion remain valid and available to deposit throughout the promotional period.
- Additional entries may be awarded through special promotional offers.

DESIGNER BAG DRAWINGS

- Fifty (50) winners will be randomly drawn from a unique and designated electronic drawing barrel between 10:00 AM and 10:00 PM on Sunday, May 14, 2023 and again on Sunday, May 21, 2023. One-hundred (100) total winners will be drawn between the two (2) designated drawing dates.
- Drawn winners must be actively playing at a slot machine or table game at the time of drawing to be eligible to win.
- Verified winners will select one (1) designer bag on display.
