OFFICIAL RULES

Earning Entries into Red Envelope Drawings

- Crescent Club members receive one (1) free entry and may accumulate one (1) additional entry for every one (1) base point earned in game play.

- Guests must deposit their entries at any Crescent Club kiosk beginning at 11:00 AM to be eligible to win each promotional drawing day.

Red Envelope Drawings
