

### **OFFICIAL RULES**

#### QUALIFYING AND WILD CARD DRAWINGS

# EARNING ENTRIES INTO QUALIFYING AND WILD CARD DRAWINGS

- Crescent Club members receive one (1) free entry and may accumulate one (1) additional entry for every one (1) base point earned in game play.
- Entries may be earned beginning at 12:00 AM on Saturday, February 24, 2024 through 6:00 PM on Friday, March 29, 2024.
- Entries earned for this promotion remain valid and available to activate throughout the earning period.
- Guests must activate their entries at any Crescent Club kiosk beginning at 12:00 PM to be eligible to win each promotional drawing day.
- Additional entries may be awarded through special promotional offers.

# QUALIFYING DRAWINGS | MARCH 1, 8, 15 AND 22

- Sixteen (16) winners will be selected at random from a designated electronic drawing barrel between 2:00 PM and 6:00 PM on March 1, 8, 15 and 22, 2024.
